Licensed Judges fee applies to Licensed Allbreed and Licensed Single Specialty Judges. A Specialty Judge – possessing a Licensed Specialty AND the opposite Probationary Specialty license – both fee rates apply.

Licensed Allbreed and Licensed Specialty

\$1.25 / cat entered on the day the judge is officiating in the show catalogue. **(number of cats)** _____

A minimum of \$125 if less than 100 cats are entered in the show OR \$62.50 if less than 50 cats in a single Specialty.

Probationary Specialty

\$0.65 / cat entered on the day the judge is officiating in the show catalogue. **(number of cats)** _____

A minimum of \$32.50 if less than 50 cats are entered in the Specialty class being handled.
